

WAIVER AND RELEASE AGREEMENT

Please read carefully before signing. This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of Camp Kay Outfitters, I agree to the following Waiver and Release:

I acknowledge that hunting has inherent risks, hazards, and dangers for anyone, which cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and or archery equipment and being near others that have firearms or archery equipment in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking in rugged county, including encounters with wildlife, animal and insects;
4. Inclement weather conditions;
5. The risk of injury from riding on an all terrain vehicle (ATV) or any vehicle used off the paved road;
6. The risk of injury from the use of tree stands;

I understand the risks, hazards, and dangers of hunting and have had the opportunity to discuss them with Camp Kay Outfitters. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe that I have good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

I AM VOLUNTARILY USING THE SERVICES OF CAMP KAY OUTFITTERS WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, AND DEATH.

Lastly, I, for myself, my heirs, successor, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Camp Kay Outfitters, MKR Farms LP, Milton Cole, Mark Liebner, their directors, members, officers, agents, employees, and volunteers, from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to,

arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage , loss, injury, paralysis, or death results from negligence of Camp Kay Outfitters or from some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue Camp Kay Outfitters, MKR Farms LP, Milton Cole, Mark Liebner, their directors, members, officers, agents, employees, and volunteers as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of Camp Kay Outfitters.
